



APPLICATION FOR PAYMENTS TO HORSE OWNERS – COVID-19

Ontario Racing is reallocating a portion of existing purse funding paid by Ontario Lottery and Gaming Corporation (“OLG”) under the Amended and Restated Funding Agreement for Live Horse Racing to horsepeople who do not have the opportunity to compete for purse winnings during the suspension of horse racing in Ontario in response to the COVID-19 pandemic. These payments are intended to be used for the sole purpose of paying trainers’ invoices in support of the health, welfare and training of horses. In order to be eligible to receive payments from Ontario Racing, horse owners or their designates are required to complete and sign this application which must be submitted to Ontario Racing Management Inc. (“ORM”). **For those owners who have multiple breeds, one application per breed is required.** Ontario Racing reserves the right to accept or reject any application in its sole discretion, and to impose additional conditions relating to payments made pursuant to this application.
